2. Detailed Terms and Conditions in respect of the proposed auction are given below:
- The interested parties should have valid permit/registration for buying the scrap/obsolete/e-waste items given in the list attached at annexure-I.
  - The disposal of the said items will be done on "As Is Where Is Basis".
  - The auction will be held in the **Embassy of India, 45, Shatt Street, Tripoli, Libya on 28.07.2025 at 1100 hrs.**
  - A Pre-auction/Inspection meeting followed by site visit (on appointment basis) would be held in the office of Head of Chancery, Embassy of India, 45, Shatt Street, Tripoli, Libya during 11 am to 1 pm in office hours wherein the interested parties may inspect to apprise themselves of the items for auction. The interested parties who require any clarifications and want to inspect the may send their requests to [hoc.tripoli@mea.gov.in](mailto:hoc.tripoli@mea.gov.in) or [admn.tripoli@mea.gov.in](mailto:admn.tripoli@mea.gov.in) for booking appointment for the site visit as well as for participating in the auction.
  - During the auction process, bidders will be asked to quote the offer price of individual item for sale. Bidder quoting the highest price will be declared successful. Acceptance or rejection of a bid will be announced immediately after the auction.
  - Sale of the item to the successful bidder shall be decided only after following due procedure by the Auction Committee of the Embassy.
  - From the successful bidder, earnest money (not less than 25% of the bid value) will be immediately taken on the spot in cash. Then a Sale order will be issued. However, the goods will be released to the successful bidder only after receiving the full payment which will not be later than 3 days from successful bidding. EMD will be forfeited if bidder withdraws or derogates from the bid in any respect.
  - The goods have to be lifted by the successful bidder on his own not later than two days after the complete payment.
  - The Labour, transportation and any other charges will be borne by the successful bidder. It will be the sole responsibility of the successful bidder to ensure the safety of the structure and other materials to save them from damage etc. at the time of removing, shifting the machinery etc.
  - The employees of the Embassy of India, Tripoli are not eligible to take part in the auction.
  - No items**, once sold to the successful bidder, shall be taken back by the Embassy, in any condition whatsoever.
  - The Competent Authority reserves the right to reject any or the all offer price without assigning any reason and the decision of the competent authority of the Embassy shall be final and binding.
