### VISA PROCEDURE & FEE STRUCTURE

### **ONLINE VISA APPLICATION SYSTEM**

The Embassy of India, Tunis has shifted to <u>Online Visa Application System</u> w.e.f. 27<sup>th</sup> March, 2014. From now onwards, Visa forms in the old format shall not be accepted. All the applicants are requested to apply online by visiting the link <u>http://indianvisaonline.gov.in/visa/</u>

#### **NEW VISA PROCEDURE GUIDELINES**

- Applicants are required to fill online visa applications according to the instructions given in the above link and upload the digital photos.
- Applicants should choose Indian Mission "Tunisia-Tunis" and note down the temporary Application ID mentioned on the webpage.
- Applicants are required to verify the application details before submitting the online application. They have an option to save the online application form, in case it is not to be submitted. The same can be re-accessed by entering the Temporary Application ID.
- Once the online application form is submitted by the applicant, then further modifications are not allowed. Hence applicants are requested to check and validate the details before submitting the online application form.
- On submission of the online form, a Web File Number starting with TUNT will be generated. Applicants are requested to keep this file number for further communications regarding their visa application. This web file number can be used for Visa Status Enquiry.
- A printout of duly submitted online form should be signed by the applicant and presented in person at the Embassy during Consular Service hours along with requisite fees, two recent photographs (5.08cm X 5.08 cm, 2" X 2") and all other documents required for issuance of visa.
- The new machine readable Visa sticker issued by the Mission will be valid for entry into India, although it may not have signatures and stamp from the Embassy.

### Applications acceptance timing: 9:00 AM to 12:00PM (Monday to Thursday).

### Delivery of passports with affixed visa: 3:00 PM to 4:00 PM (Monday to Thursday).

Passports will be delivered strictly on production of original receipt issued from the Embassy.

TD 4.000 towards ICWFund will be charged for each application from the applicants.

### **Requirements for Tourist Visa**

Duly filled in visa application form should be submitted along with following documents:

- 1. Two recent (not older than 3 months) color passport size photographs.
- 2. Valid current passport (at least 6 months validity with two blank pages for affixing visa) and previous passports.
- 3. Copy of National Identity Card and Passport.
- 4. Copy of confirmed return tickets.
- 5. Bank statement of three months, with a minimum balance of TD 1500.000.
- 6. Copy of valid travel assurance.

#### **Requirements for Business Visa**

Duly filled in visa application form should be submitted along with following documents:

- 1. Two recent (not older than 3 months) color passport size photographs.
- 2. Valid current passport (at least 6 months validity with two blank pages for affixing visa) and previous passports.
- 3. Copy of National Identity Card and Passport.
- 4. Copy of confirmed return tickets.
- 5. Bank statement of three months, with a minimum balance of TD 1500.000.
- 6. Copy of valid travel assurance.
- 7. Invitation letter from Company in India.
- Letter from applicant's company (Order De Mission) sponsoring the business visit to India indicating nature of applicant's business, duration of stay, places and companies to be visited in India.
- 9. Copy of Business Registration Certificate (Company registration) issued by the Tunisian authority.
